Supervisor Gallant opened the meeting and had Clerk Wicks read the public notice calling for the Public Hearing on the realignment of sewers in the West Sand Lake four corner areas.

Supervisor Gallant then turned the meeting over to the Kestner's who made a presentation of the events and decisions that have brought the matter to a public hearing.

The meeting was then opened to questions and each person was requested to give their name and address before making a statement.

The Court Reporter has transcribed the hearing and the full text of the meeting will be available after it is transcribed.

At the close of the meeting Supervisor Gallant complemented the people on the orderly fashion that they had conducted themselves. He also complemented the Kestners' on their presentation and on their dedication and cooperation. He also commented on the problems of dealing with large government agencies.

TOWN OF SAND LAKE BOARD MEETING JANUARY 10, 1979

The regular monthly meeting of the Town Board of the Town of Sand Lake was called to order at 7:30 p.m. at the Town Hall, Sand Lake, New York. After the Pledge of Allegiance, the following answered roll call:

Also present were: Bob Fickes and John Smead for Cable TV, Tom Cipperly, Jean Pryor, Ted Maycheck, Marie Lynam, John Miadzielec, Joe Warren, Don Hastings, Bob Lilly, Dan Holser, Bernie Baniak, Emma Wicks, Dave Biittig, Bill Walsh, Bernie Bresnahan, Bill Behrens, Nancy Dyer, Charolotte & Bill Foster, Ken Martin and others.

The minutes of the December 13th and December 27th were approved as corrected on a motion made by Councilman Patti, seconded by Councilman Shoemaker. The correction was that Councilman Patti asked that the minutes of December 13th show that Ken Martin made the report for Cable TV.

The Town Clerk's report was approved on a motion by Councilman Udwary, seconded by Councilman Patti.

The Supervisor's report was not ready and will be given at the February meeting.

The Police Report was given by Chief Teidman.

The Sand Lake Ambulance report was read by John Miadzielec.

The Zoning Officers report will be given next month.

General Fund Warrant #1 in the amount of \$176,548.55 was approved on a motion by Councilman Udwary, seconded by Councilman Patti.

Machinery Fund Warrant #1 in the amount of \$1,051.84 was approved on a motion by Councilman Udwary, seconded by Councilman Patti.

Correspondence: The following was noted under correspondence: The official notice of the Association of Towns meeting at New York City on February 18th, 19th, 20th and 21st, the planning board minutes of January 3rd, 1979. A letter from the Black River Raider's offering their services in the event of an

emergency, from Cole-Air-Trumble asking for office space at the Town Hall for about six months while making their survey. The board will investigate.

Committee Reports: Roads & Streets & Landfill, Bresnahan: The Superintendent of Highways has requested people to keep their cars off the highway during snowplowing operations in order to speed up the snow removal. On the Landfill the State Engineers are not satisfied with the engineers report. They will have a new report modified as to their requirements.

Lighting District, Senior Citizens, & Insurance; Shoemaker: He reported (1) light out and read the annual report of the Senior Citizens.

Machinery, Street Signs & Cable TV; Patti: He has asked residents to advise him of any missing Street Signs. He then turned his report over to Ken Martin, and Mr. Smead to discuss Cable TV. They asked that a letter be written requesting the addition of 2 more channels. One from a station in New York and one from a station in Utica. These channels are available to other cable companies and they feel that they should be available to the town as well. The progress of installing cable is proceeding in a fine manner. They presented a map showing the areas that have been cabled both in the franchise and areas done not in the franchise. They asked the board to consider allowing them not to cable some areas in the franchise due to lack of density in the area. Councilman Patti will write to the New York State Cable Division to find if the board may change the franchise.

A resolution was offered by Councilman Patti, seconded by Councilman Bresnahan to petition the FCC to permit the Rensselaer Cable Company to add a channel from New York City and Utica to the present system. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

Youth Recreation, Budget & Finance; Udwary: Councilman Udwary reported that they are working on setting up the double entry bookkeeping system as mandated by New York State.

Town Building & Police Commission; Gallant: The Police Commission will meet on the 16th of January. The work on the addition to the Town Garage for the police vehicles has been stalled because of the bad weather. Supervisor Gallant read the update letter from the Kestner firm regarding the progress on the sewer district. He has signed a request for funds from EPA.

Clerk Wicks read the public notice for bids for a new police car. He then opened bids form Ken Goewey Dodge in the amount of \$6,867.00 with \$150.00 trade. A bid from Bumstead Chevrolet for \$7,850.00 with a \$50.00 trade.

Clerk Wicks then read the public notice for bids for a used piece of equipment for the Landfill. The bids received were from Southworth Machinery \$42,500 less \$15,500 in trade. From Danbar \$55,500 less \$17,500 in trade. From K.C. Canara \$55,000 less \$16,600 in trade. A motion was made to table all bids in order for the machinery committee to review the bids and a special meeting was called for Tuesday, January 16th at 7:30 p.m. at the Town Hall. The motion passed.

The following organizational items were then acted upon.

A resolution was offered by Councilman Udwary, seconded by Councilman Patti that the Town Board meetings for 1979 be held on the 2nd Wednesday of each month at 7:30 p.m. at the Town Hall, Sand Lake, N.Y. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Shoemaker that the Troy Times Record be designated as the official newspaper. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Shoemaker, seconded by Councilman Bresnahan that the Troy Times Record, WTEN, WGY and WPTR be designated as the Official news media to report town meetings too. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

On the next item Supervisor Gallant read a proposal from Community State Bank and a letter from Citibank explaining their services available to the Town. After the presentation a resolution was offered by Councilman Patti, seconded by Councilman Shoemaker that Citibank be designated as the official bank for the Town of Sand Lake. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Udwary, seconded by Councilman Bresnahan that the mileage allowance for Town Officials using their private automobiles on Town Business be 15 ¢per mile. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Udwary, seconded by Councilman Patti authorizing elected and appointed Town Officials to attend the Association of Towns Meeting to be held in New York City on February 18th, 19th, 20th and 21st. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Udwary, seconded by Councilman Bresnahan that Carl E. Wicks be appointed as delegate to the Association of Towns and John Udwary be appointed as Alternate to the Association of Towns meeting. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Patti that the Town of Sand Lake participate in the New York State Youth program for 1979. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Shoemaker, seconded by Councilman Bresnahan that the Supervisor be authorized to deposit Town Funds in Certificates of Deposit at the best possible interest rates. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Udwary that Highway Personnel and Environmental Personnel be paid as established in the 1979 budget. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Shoemaker that Elected and Appointed Town Officials be allowed a maximum of \$200.00 toward expenses while attending official meetings for the Town. Payments are not to exceed actual expenses. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Udwary, seconded by Councilman Bresnahan that Elected and Appointed Town Officials be paid as stipulated in the 1979 budget. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Patti, seconded by Councilman Shoemaker that Town goods be purchased under state contract when to the advantage to the Town. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Bresnahan, secnded by Councilman Shoemaker that Highway Employees, the Environmental Control Employee and the full-time Police Officer be paid on a Bi-Weekly basis. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Udwary, seconded by Councilman Bresnahan that Justice Breigle be appointed the Judge for delinquent dog owners. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A resolution was offered by Councilman Patti, seconded by Councilman Shoemaker that Charlotte Foster be appointed as the Secretary to the Supt. of Highways. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

Cora Hoffay asked if the bond that the Town requires for her gravel bank could be waived as the State of New York now requires one. Attorney Werger will investigate and report at the February meeting.

Clerk Wicks reported that he had checked with the Freedom of Information agency in Albany and they advised him that Mr. Dobert did have the right to privacy over his financing Bon Acre Mall and

that the Town could convene an executive meeting during a regular Town Board meeting for this purpose.

Regarding the petitions from Judge Rowe, Supervisor Gallant recognized Clerk Wicks.

Clerk Wicks first explained the article in the Record Newspapers. He stated that he did not hold court, that he was not a Judge. He corrected the statement that the Towns business was conducted in his insurance office. He then pointed out that it was Mr. Bernard Baniak who made statements that were referred to as "". Mr. Wicks stated that the statements made were not true and that Mr. Baniak owed the Town Board an apology. Mr. Wicks then referred to a statement in the paper that said he did not have much to say. Wicks stated that he gave a specific reason for not having anything to say and that was that he had not seen the petitions and that he would not have anything to say until the next regular meeting. He also stated that he had not as yet received the petitions. Supervisor Gallant then turned the petitions over to Clerk Wicks which made them an official record of the town.

Mr. Wicks then stated that his budget for 1979 was \$8,050.00 which paid his salary and his deputies as well as his office expenses. This compares to other towns with full-time Town Clerks that were making about \$10,000 in salary aloe with budgets running as high as \$20,000. He stated that he was giving the residents the best possible service at the least possible expense in running the office at West Sand Lake. He asked the board that because it was a personnel problem that if there were to be any future discussion on the subject that it be conducted in executive session.

A resolution was offered by Councilman Udwary, seconded by Councilman Besnahan that the Town Board go into executive session. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Abstain, Shoemaker – Yes.

After the executive session a motion was made by Councilman Bresnahan, seconded by Councilman Shoemaker that the Town Clerk Office discussion be tabled until the February 14th meeting. The motion carried.

Attorney Werger advised the board that the manner in which Supervisor Gallant tendered his resignation effective March 31st, 1979 was improper. He then presented a resolution to correct the matter. The entire resolution becomes an additional page of these minutes.

Supervisor Gallant announced that all appointments will continue until his resignation on March31st, 1979 at which time the newly appointed Supervisor will make his own appointments.

Town Clerk Wicks presented his books for audit. Supervisor Gallant will have books ready in February.

Town Clerk Wicks read his annual report. Supervisor Gallant will have his annual report ready in February. Justice Breigle's annual report was also read.

Supervisor Gallant read a Memoriam to Harold E. Harriman. The Memoriam becomes an additional page of these mimutes.

A motion to adjourn was offered by Councilman Bresnahan, seconded by Councilman Udwary at 10:20 p.m.

The minutes of the January 9th and January 16th were approved as submitted. The minutes of the January 10th meeting were approved as amended as follows; the cable TV comments were amended to read that the letter to the Cable Commission would ask if the Cable Company has the right to amend the cable franchise without permission of the Town Board on a motion by Councilman Patti, seconded by Councilman Bresnahan.

The Town Clerk's report was approved on a motion by Councilman Bresnahan, seconded by Councilman Udwary.

The Supervisor report was read by Secretary Donohue for the months of January and February and were approved on a motion by Councilman Udwary, seconded by Councilman Shoemaker.

The Zoning Officers report was read by Clerk Wicks.

The Police Report will be given at the March meeting.

The Sand Lake Ambulance report was given by John Miadzielec.

General Fund Warrant #2 in the amount of \$234,061.12 was approved on a motion by Councilman Bresnahan, seconded by Councilman Patti.

Highway Fund Warrant #2 in the amount of \$6,477.12 was approved on a motion by Councilman Bresnahan, seconded by Councilman Patti.

Correspondence: The following was noted under correspondence: From the Harriman family, acknowledgement of our condolences on the death of Harold, the Planning Board minutes of February 7th. Supervisor Gallant read a letter regarding equalization rates, a letter advising that Nancy Dyer had completed Phase II of assessment training.

Committee Reports: Roads & Streets & Landfill, Bresnahan: The highway department is combating the snow & ice. The Landfill report will be given under machinery.

Lighting District, Senior Citizens, & Insurance; Shoemaker: The Senior Citizens are holding a valentine party and in March will hold a crafts session. (1) street light was reported out. The Town's Insurance Agent is drawing up a summary of insurance coverage's for the board.

Machinery, Street Signs & Cable TV; Patti: The Police Car bid was awarded. On Cable TV: Sand Lake is one of three communities that produce their Town Board meetings live. Thanks were given to Bob Fickies. Bob Fickies is starting a program on informal discussions where citizens will be questioned and allowed to express views. This will start in March.

Youth Recreation, Budget & Finance; Udwary: He has talked with Mr. Dubus who has taught double entry bookkeeping and Mr. Debus has agreed to instruct and help setup the double entry bookkeeping system for the Town for \$200.00.

Town Building & Police Commission; Gallant: The Building Committee will meet and review the construction of the Police Garage at the Highway Garage before approving the voucher submitted. The police are to prepare a resume of the 10 years they have been in existence and project the future of the department.

Mr. Jim Brown of Taborton spoke on the overflow of the creek near the Taborton Fire House. The fire company and nearby residents have requested assistance on the overflow problem. It was explained the need for a permit from conservation and that the Town equipments would be available for cleaning the debris. Councilman Bresnahan stated that the Town would furnish gravel to build a levee when the weather permitted.

A group from Allen Ave. complained over the size of the road in width and that the high crown made cars skid into the ditches. The matter was referred to the Highway Committee. Councilman Bresnahan will arrange for the committee to meet with the residents of Allen Ave. in an attempt to make corrections.

Councilman Patti reported for the Machinery Committee regarding the Landfill e1uipment. A survey was made that indicated metal bits were appearing in the oil of the motor of the present equipment. Because of this the committee recommended that the equipment be replaced with a used piece of equipment as specified in the recent bidding. A resolution was offered by Councilman Patti, seconded by Councilman Bresnahan that the Town of Sand Lake purchase a 1974 Caterpillar 955L Traxcavator from Southworth Machinery, Inc. being the lowest of 3 bids submitted, the equipment is to be financed as follows: With a total of \$42,500.00 less trade of \$15,500.00 leaving a balance of \$27,000.00 with a down payment of \$6,000.00, the balance to be budgeted by financing a 4 year bond with annual payments plus interest. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

A letter was read by Supervisor Gallant regarding locating a facility for retarded people in the Town. Attorney Werger also read correspondence regarding the matter. Karen Myers and Ellie Pattison spoke on the subject and explained to the board how the program works. The committee would like to locate a facility in the Town of Sand Lake. They will work with and keep the Town Board informed of their activities.

Councilman Patti advised the board of an additional youth program as advised by the Division of Youth which the town is eligible and which is 100% funded by the state. A resolution was offered by Councilman Patti, seconded by Councilman Shoemaker that the Town of Sand Lake participate in the Supplemental Youth Program and that the amount of \$1,221.50 be expended and which will be fully funded by the State Youth Commission. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

The Youth Commission recommended to the board that Janet Sentz be appointed a full-time/part-time Youth Director. A resolution was offered by Councilman Shoemaker, seconded by Councilman Patti, seconded by Councilman Shoemaker that Janet Sentz be appointed the Youth Director for the Town of Sand Lake and that her pay be as established in the budget. On roll call the following votes were cast: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

Councilman Patti also announced that the Town of Sand Lake will participate in the Youth Conservation Corporation.

Attorney Werger will continue to investigate the bond situation for Mr. Hoffay and will report back at the next meeting.

Regarding a letter regarding a Social Services Substation, the matter is still being worked on.

Supervisor Gallant read letters from the Kestner's, regarding the Sewer District and from EPA regarding changing the sewer locations from the rear to the front of the residents in the West Sand Lake Four Corner area. One of the letters from Kestner was a report on when the Federal funds will be available to the Town.

Supervisor Gallant announced that the contract on reevaluation has been filed in the Town Clerk's Office.

A resolution was offered by Councilman Patti, seconded by Councilman Shoemaker that Supervisor Gallant be empowered to enter into a contract on behalf of the Town with the State of New York providing for payment by the State of a portion of the cost of construction of the Water Quality Improvement Project. The following votes were cast on roll call: Gallant – Yes, Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

Supervisor Gallant offered a motion to propose a local law to establish the location of the Town Clerk's Office at the Town Hall, Sand Lake, N.Y. and that the hours of operation of such office will be from 9:00 a.m. to 12:00 noon and from 1:00 p.m. to 4:00 p.m. Monday through Friday and from 9:00 a.m. to 2:00 p.m. on Saturdays effective January 1st, 1980, seconded by Councilman Patti and passed.

The annual reports of Historian Carpenter and Supervisor Gallant were presented to the board.

The books of the officials that were not audited at the January meeting were audited at the February meeting.

Don Hastings thanked Supervisor Gallant for his assistance with a problem at SnoFun.

The executive session with Bon Acre Mall has not been scheduled as yet.

The meeting was adjourned at 10:05 p.m. out of respect to former Vic President and Governor Nelson Rockefeller on a motion by Councilman Bresnahan, seconded by Councilman Udwary.

TOWN OF SAND LAKE BOARD MEETING MARCH 14, 1979

The regular monthly meeting of the Town Board of the Town of Sand Lake was called to order by Supervisor Gallant at 7:30 p.m. at the Town Hall, Sand Lake, New York. After the Pledge of Allegiance, the following answered roll call:

The minutes of the February 14th meeting were approved as submitted.

The Town Clerk's report was approved on a motion by Councilman Shoemaker, seconded by Councilman Bresnahan.

The Supervisor report as read by Secretary Donohue for the month of February, 1979 were approved on a motion by Councilman Udwary, seconded by Councilman Patti.

The was no Zoning Officers Report.

The Sand Lake Ambulance report was given by John Miadzielec.

General Fund Warrant #3 in the amount of \$202,286.63 was approved on a motion by Councilman Udwary, seconded by Councilman Bresnahan.

Highway Fund Warrant #3 in the amount of \$2,453.63 was approved on a motion by Councilman Udwary, seconded by Councilman Bresnahan.

Correspondence: The following was noted under correspondence: Letter from Congressman Gerald Soloman re: meeting to be held at Glens Falls for Town and City Officials on Saturday, March 31st. This was held for Town Board and other Town Officials to sign to attend at Supervisor Gallant's Office. Letter read from Voting Machine Service Center re: the damaged Voting Machine. Clerk Wicks was to be advised to write and ask price on Service Call as vs. the pickup and total price of repairs after its examination at factory. This was tabled for the April agenda. Also, inquiry as to what was wrong with machine.

Supervisor Gallant explained the Certificate of Deposit changes and what had been done for the Town's best interest.

Supervisor Gallant gave figures from the Highway Department relating to the extreme bad winter whereby more man hours and other expenses were incurred which in 1979 was \$5600 over, through February, 1978. He also stated the Town Board commended the Town Highway Department for a job well done.

Letter was read from Beryl Vannier from the Historical Society requesting permission to hold monthly meetings at Town Hall. It was discussed and then given to Attorney Werger to firm up legality; it was then tabled for the April Agenda.

Councilman Udwary read a clipping sent anonymously to him re: inflation. He stated he thought this rate inflation message was more or less and indication of someone's message to the Town Board to keep expenditures down. During a very slight discussion it was shown by the Supervisor's Report that the Board made every attempt in that same direction and so emphasized by same.

Committee Reports: Roads & Streets & Landfill, Bresnahan: Culvert pipes, et al to eliminate flooding at areas in the Town. He stated re: Landfill – still waiting for new machine – no delivery date as yet for same.

Lighting District, Senior Citizens, & Insurance; Shoemaker: Senior Citizens held a St. Patrick's Party and they will have Crafts starting this week. Lighting – Had four lights reported out and to the best of his knowledge they were all repaired. Insurance – No Summary received as yet. Deputy Bailey advised he would receive for April meeting.

Machinery, Street Signs & Cable TV; Patti: He stated there was no report. Supervisor Gallant said there was a missing sign near Stephen Gallant's home and also in the West Sand Lake Extension. The Mountain View sign is now at the Highway Garage. He also stated that the Budget was expended. The Highway Department will be advised and when time allows they will put up the sign. It was suggested by Supervisor Gallant that signs be investigated that are welded in rather than screwed on which would make it more durable and harder for vandalism. Also, the request this year from Man Power for putting up sign, painting and so forth. The Man Power program seems to be working well for the Town when it has been used and the Board has been pleased with results. Councilman Patti turned the Cable TV over to Ken Martin who stated construction in all outlying areas complete and installed with the exception of Burden Lake. He also stated they have been advised by the State that the request for extensions come from the Cable Company – Amendment – Abide by Contract as signed.

The Annual Report was deferred to the April Meeting.

Access – Cable Commission Expansion. The first area was the Special Sewer Line Meeting. They are also starting – Sand Lake Sunday Talk Shows – which will be live on Channel 18 and then shown on tape on Channel 16 Thursday and Friday. Those planned so far are Congressman Ned Pattison, Historian of the Town, Madolyn Carpenter, Reassessment Problem, Maria Lyman plus other associated with this field and others are being planned for. Those involved will be conracted. Financial check – final quarter 1978 - \$217 – Total \$1158 (15 months) plus \$15 Franchise and small expenditures approximately \$200. Discussion was held on a better sound system for the T own Board meetings which would cost approximately \$200 and it was unanimously approved. Re: the expenditures discussed voucher is needed for presentation.

Youth Recreation, Budget & Finance; Udwary: He has talked with Mr. Dubus who has taught double entry bookkeeping and Mr. Debus has agreed to instruct and help setup the double entry bookkeeping system for the Town for \$200.00.

Councilman Patti re: Youth Commission stated the appointed Youth Director, Janet Sentz and since appointment due to Doctor's recommendation due to pregnancy she will have to resign and therefore declined the appointment.

Youth Recreation – Budget & Finance: Councilman Udwary reported he has been meeting with Supervisor Gallant re: accounting and office procedures for transition in office. Youth Recreation – Progress is being made in getting started at Youth Recreation Field when weather permits. Consideration is being given for renting equipment for this operation.

Town Building & Police Commission; Supervisor Gallant: No Police Commission Report. Town Building – addition to Town Building to house police cars, the Committee met with the Contractor regarding heating and electrical service. An approximate estimate and scale drawing was presented for same. This is mainly outside work and the cost \$31,000 – of which \$28,000 has been disbursed and on completion to the Building Committee's satisfaction the final payment will be made.

Sewer District – Supervisor Gallant – Each member of the Town Board and Town Clerk and Secretary Donohue have the March 1, 1979 Monthly Progress Report. He also advised re: the Bon Acre Mall executive session meeting; that he had not been able to reach all concerned and hopefully by the end of the week he will be able to advise Clerk Wicks so it may appear on the April Agenda.

Supervisor Gallant stated that he had attended a meeting with Assessor Maria Lyman and Nancy Dyer, Clerk and stated both Mrs. Lyman and Mrs. Dyer were to be commended on their work done before and after this meeting and for their detailed questions and also discussion held for the Town's benefit so they could bring back all exact information. There has been a total review which is to be presented to the Equalization Board. Letter received this date and will now be sent to the next group necessary.

Supervisor Gallant read a letter from Four Doors Down – Thrift Shop, requesting a substation for Town Residents for Food Stamps. Mr. Richman has authorized units through County Office Building. Also received with same were application forms and forms for specific procedures for obtaining Food Stamps. These will be at the Town Clerk's Office for availability for those who wish to request aid through Food Stamps for the convenience of the Town of Sand Lake residents. They will however have to be made out by the individuals and if there are any questions they will have to call the County Office for information.

The Supervisor of the Town will be contacted by the Federal Census Bureau for the purpose of taking same in 1980. In 1970 there were 5,843 residents and as of July 1, 1976 an estimate of 6,352 residents. This information is on file in the Supervisor's Office.

All town Board Members, Clerk Wicks and Secretary Donohue were presented copies for Revaluation of Real Property.

Re: CETA – Supervisor Gallant stated we have one employee – William Freeman – and he attended a conference at Hudson Valley Community College and stated he is in complete non-agreement to abolish this system. Not one Federal Representative wrote, phoned or appeared and they are trying to cut this program out. Supervisor Gallant requested our Town to fight for CETA to keep same. He also stated that no one from the State level ever appeared to see what was going on. Towns are suffering from mismanagement due to larger cities management of the program which was brought up at this meeting.

It was announced that Audit of Town by the Department of Audit and Control from 1/1/74 to 12/31/78, copies on file in the Supervisor's Office and Town Clerk's Office for public review.

The legality on the changing of the Town Clerk's location and hours of operation was given by Attorney Werger. A Legal Notice is to be put in the paper stating the Sand Lake Town Board will hold a Public Hearing at 7:30 p.m. on April 11, 1979 at the Sand Lake Town Hall in the matter of the passage of

Local Law #1. All persons desiring to be heard in this matter will be heard at this meeting. On a motion by Councilman Bresnahan, seconded by Councilman Udwary.

Supervisor Gallant stated that in December he submitted letter of resignation dated March 14, 1979 to be effective March 31, 1979 and at the same meeting gave his reasons for doing so. Letter was read and copies were given to Town Board members and the original to the Town Clerk. He stated for all concerned to be assured in this transition period he is not locking the door and will assist in anyway possible working with all. Attorney Werger then read the legal ruling for appointment for the vacancy to hold the Office of Supervisor for the unexpired term and that there were 30 days to fill such vacancy.

Donald Hastings then thanked Robert LaFleur and Supervisor Gallant for solving his problem.

Bernard Baniak called for a rising vote of thanks to Supervisor Gallant for his years of service and what was accomplished.

The meeting was adjourned on a motion made by Councilman Bresnahan, seconded by Councilman Patti at 8:55 p.m.

TOWN OF SAND LAKE BOARD MEETING APRIL 11, 1979

The regular monthly meeting of the Town Board of the Town of Sand Lake was called to order by Deputy Supervisor John Udwary at 7:30 p.m. at the Town Hall, Sand Lake, New York. After the Pledge of Allegiance, the following answered roll call:

Deputy Supervisor Udwary read a letter resigning as Councilman.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Patti that John Udwary be appointed Supervisor of the Town of Sand Lake to replace former Supervisor Sidney Gallant until the expiration of the term which is December 31st, 1979. The following votes were cast on roll call: Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

Clerk Wicks then administered the Oath of Office to Supervisor Udwary.

A resolution was offered by Councilman Patti, seconded by Councilman Shoemaker that Donald Savage be appointed as Councilman to fill the unexpired term of Councilman vacated by John Udwary with his resignation as Councilman. The term expires on December 31st, 1979. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

Clerk Wicks then administered the Oath of Office to Councilman Savage.

Supervisor Udwary then appointed Luke Bresnahan as Deputy Supervisor.

Clerk Wicks then administered the Oath of Office to Deputy Supervisor Bresnahan.

Supervisor Udwary then recessed the meeting to go into a Public Hearing regarding location and hours of the Town Clerk's Office.

Clerk Wicks read the public notice calling for the Public Hearing.

Supervisor Udwary read a letter from Catherine Bradley giving her opinion that the Clerk's Office should be located at the Town Hall.

The entire public hearing was recorded by Mario Rizzi a Court Reporter and the entire transcript will be on file in the Town Clerk's Office.

Supervisor Udwary reconvened the Town Board meeting at about 9:15 p.m.

The minutes of the March 14th meeting were approved on a motion by Councilman Patti, seconded by Councilman Shoemaker. The motion passed with Councilman Savage abstaining.

The Town Clerk's report was approved on a motion by Councilman Patti, seconded by Councilman Shoemaker.

The report of Supervisor Gallant for the month of March and reach by Supervisor Udwary was approved on a motion by Councilman Bresnahan, seconded by Councilman Patti.

The Zoning Officers reportwas read by Clerk Wicks.

The Police Report was read by Lt. McNaney.

The Sand Lake Ambulance report was read by Tom McKeon.

General Fund Warrant #4 in the amount of \$157,763.40 was approved on a motion by Councilman Patti, seconded by Councilman Shoemaker. Councilman Savage abstained.

Highway Fund Warrant #4 in the amount of \$3,669.38 was approved on a motion by Councilman Patti, seconded by Councilman Shoemaker. Councilman Savage abstained.

Correspondence: Councilman Patti read a letter from Unity House about public information for groups, etc.; Clerk Wicks reported on his letter advising the County Clerk of Supervisor Gallant's resignation; A letter from the Dept. of Agriculture & Markets advising of a night quarantine on dogs in Rensselaer County; a map of the New York State Coast as provided by the Coastal Management Program; a letter from the Rensselaer County Clerk regarding the Town issuing parking permits for disabled persons.

A motion was made by Councilman Bresnahan, seconded by Councilman Patti that he Town Clerks Office be authorized to issue parking permits for the disabled. The motion passed.

A letter read by Supervisor Udwary from Pine Tree Lane requesting that a sewer line not be built to serve their properties; A letter from N.Y. Equalization & Assessment with the proposed new Equalization rate; from the N.Y. Telephone Co., regarding costs and rate changes; from the County Executive advising of an executive meeting on April 19th, 1979 at the new County Offices; from Kestner Assoc with the monthly sewer report; from the CDTA regarding appointments to committee's; from the NYS Dept of Audit & Control regarding taxes becoming due on exempt property when transferred to non exempt status.

Also under correspondence from the regional planning commission regarding County Government functions from the Dept of EnCon regarding specifications for West Sand Lake; from the Receiver of Taxes regarding her final report; Attorney Werger regarding the location of a proposed facility for the retarded on West Shore Drive, Burden Lake; from John T. Powers regarding drainage problems on Lawson Road. this was turned over to the highway committee.

Committee Reports: Roads & Streets & Landfill, Bresnahan: The Supt. of Highways is on vacation, ditching is being done at various locations; the landfill machine has not been delivered as yet.

Lighting District, Senior Citizens, & Insurance; Shoemaker: He read a letter from he Home & Urban Development Agency regarding a hearing on the flood survey, a meeting will be held on Tuesday, April 17th at 7:00 p.m. at the Town Hall. He has received a resume of the Town Insurance and reported that the insurance premiums were about \$5,000 less than budgeted.

Machinery, Street Signs & Cable TV; Patti: he reported that he had a reply from the NYS Cable Commission and had written Mr. Schmead of Rensselaer Cablevision but had no reply. There is no delivery date on the police car that was ordered. The Youth Commission has invited youth to train on camera operations for cable TV, on Youth Commission: Carolyn Nash was recommended as Youth Director to replace the previous director who had resigned.

A resolution was offered by Councilman Patti, seconded by Councilman Bresnahan that Carolyn Nash be appointed as a part-time Youth Director. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

He also reported that there will be a Youth Core Project in the Town of Sand Lake at no cost to the Town. The project will involve the creek shore on Rt. 43 across from Dr. Goewey's Office. Applications are available for those wishing to be part of the Summer Youth Program.

Town Buildings, Police Commission and Sewer District: The Police garage is near completion. Attorney Werger reported that there would be 3 meetings in May to explain and assist persons on easements for the West Sand Lake project.

Councilman Patti offered a motion, seconded by Councilman Bresnahan that the Town Board go into executive session to discuss the proposed local law regarding the Town Clerk's Office. The motion passed.

After the executive session a motion was made by Councilman Bresnahan, seconded by Councilman Patti that the Town Board study the transcript and review hours and resubmit a new proposed local law.

Regarding the request of the Historical Society to use the Town Hall facilities for meetings. Attorney Werger stated that there is no provision for town facilities to be used for private use.

The matter regarding the contract with the State of New York for street opening was deferred to the next board meeting in order for Attorney Werger to review the proposed contract.

Clerk Wicks explained the defect in the voting machine and explained that it would be necessary to ship it to the repair facility for repairs anyway. A resolution was offered by Councilman Bresnahan, seconded by Councilman Patti that the voting machine be shipped to the Voting Machine Service Center at a cost of \$75.00 in order for them to provide the Town with an estimate of the cost of repair. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

The Building Committee reported on the Police Garage. No electric or no heat has been installed. Members of the Committee reported on prices they had gotten for electric and heat. The Committee will get additional prices and look into the cost of operation of electric heat as opposed to oil heat.

Supervisor Udwary advised the board that there were vacancies on the Planning Board and the Zoning Board of Appeals. He will meet with the board and review applicants before making an appointment.

A public meeting date will be set for providing information on revaluation to town residents.

Clerk Wicks reported on his attending the Association of Towns meeting in New York in February. He advised the board on the new dog control regulations coming from the Department of Agriculture and Markets and advised the board that some action would have to be taken by September in order to prepare a fee schedule for next years licenses.

He also reported on action proposed by the Association to the Legislature to assist towns in the high cost of municipal insurance.

Supervisor Udwary reported that the desk and chair in the Supervisor's office have been donated to the town by former Supervisor Gallant.

A request for rezoning of the Charles Land Estates has been deferred as no information has been furnished to Attorney Werger for his review.

Walter Howard & Richard Halse appeared in person to request a zoning change on Rt. 43 & 66 between Averill Park and Sand Lake from residential to Commercial. Mr. Halse read a request signed by several residents in the area. He was referred to the Planning Board for further action.

Supervisor Udwary made the following appointments:

Councilman Bresnahan - Chairman of the Police Commission Councilman Shoemaker - Chairman of the Building Committee

Attorney Werger requested the board to consider adopting (2) resolutions pertaining to the Sewer District.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Shoemaker that the Town advertise for bids for the construction for that phase of the Sand Lake Sewer District #1, known as the West Sand Lake Area, Contract #3. On roll call the following votes were cast: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Patti ratifying a resolution of September 22nd, 1976 to include the present Supervisor or any Successor to officially represent the Town in all matters concerning the said Sand Lake Sewer District #1. The entire resolution becomes an additional page of these minutes. On roll call the following votes were cast: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

Persons attending the meeting made the following comments:

John Reardon accused the board of violating the Open Meetings Law when they went into executive session.

Bernard Baniak questioned the notice of the public hearing as published in the Record Newspapers as he had not seen it. Mr. Werger showed him the official notice.

Former Supervisor Gallant asked if under the new dog control law would Rensselaer County return unused funds to the Towns. Clerk Wicks advised him that there was a provision in the law that authorized these payments.

The meeting was adjourned at 11:25 p.m. on a motion made by Councilman Bresnahan, seconded by Councilman Patti.

The Town Clerk's report was approved on a motion by Councilman Bresnahan, seconded by Councilman Shoemaker.

There was no Zoning Officers report.

There was no monthly Police report. It was noted that the new police vehicle had arrived.

The Sand Lake Ambulance Report was read by John Miadzielec.

General Fund Warrant #5 in the amount of \$220,290.07 was approved on a motion by Councilman Patti, seconded by Councilman Savage.

Highway Fund Warrant #5 in the amount of \$6,030.36 was approved on a motion by Councilman Patti, seconded by Councilman Savage.

Correspondence: To John Buono, County Clerk, advising him of the recent resignations and appointments; To the Voting Machine Service Center, authorizing picking up the defective voting machine; From the Dept. of Transportation, regarding a stop sign at Orient Ave, and RT 43; From Clinton Dunne, Inc., a certificate of insurance for County Excavation; The April 4th minutes of the Planning Board; From Madolyn Carpenter, regarding sale of Town Histories; From Kestner Engineers, regarding a meeting on a loan from Farmer's Home Administration which was attended by Supervisor Udwary and Clerk Wicks; A petition from Woodlawn Drive to Rensselaer Cablevision, regarding installing cable TV on their street; From The Rensselaer County Executive, regarding dedication of the new office building; From the State Energy Office, regarding a Public Hearing on the energy master plan to be held in Albany on May 14th; From R.J. Finegan, a recap of the Assessors Meeting on April 26th and a recap of the Steering Committee meeting on April 25th; From the Rensselaer County Sewer District, explaining when they anticipate their facilities will be ready for the towns use; From Adams Russell, regarding Cable TV financial report; From Vanderhyden Hall, regarding locating a facility in the Town of Sand lake for the Retarded; From the Planning Board, an application for rezoning for Jerome & Edith Hunt; From Kiwanis, thanks for the Towns assistance in the Spring cleanup.

Committee Reports: Roads & Streets & Landfill, Bresnahan: The Highway Dept. is grading roads and preparing for oiling. The new piece of machinery has arrived at the Landfill and is in use.

Lighting District, Senior Citizens, & Insurance; Shoemaker: There were no street lights reported out. A new contract with the Electric Company will be discussed later on in this meeting. They had a meeting on Flood Insurance on April 17th. He advised the board of a notice of claim for \$800,000. He also reported that the committee had met with an insurance consultant.

Machinery, Street Signs & Cable TV; Patti: A survey of street signs needed will be conducted this summer. They have (8) men under the speed project this year. High School youths have been asked to participate in a training program for cable transmissions. He reviewed the status of the Burden Lake Area for Cable. The Towns fees earned were \$240.80. The sound equipment for the Town is being negotiated. Jean Heather has been appointed as the water safety program director.

Youth Recreation, Budget & Finance; Udwary: The services of John Donohue have been terminated as Town Auditor. Areas of the softball field have been reseeded. He has quotes on rental of equipment for additional work but has not been able to locate an operator.

Town Buildings; Shoemaker: The police garage has been accepted from the contractor.

Sewer District: Attorney Werger requested the board to give him permission to return the old easements for the West Sand Lake area. A resolution was offered by Councilman Bresnahan that he easements taken in the West Sand Lake Area that are no longer necessary be returned by the Town Attorney at his discretion, seconded by Councilman Patti. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

Under the Supervisor's Administrative matters, Mr. Udwary read a list of Committee Appointments a copy of which will become a part of these minutes.

A motion was made by Councilman Patti, seconded by Councilman Bresnahan authorizing Town Clerk Wicks to advertise for bids for Grade 1 & 1A stone for the use of the Highway Department for 1979, the bids are to be returnable at 7:30 p.m. on June 13th, 1979. The motion passed.

Attorney Werger advised the board that a Town Highway was infringing on property owned by a Mr. Peters in Ravers Sunny Acres. Mr. Peters would like to settle the matter with the Town. The Highway Committee are to arrange to meet and review the situation and then make some arrangements with Mr. Peters.

A resolution was offered by Councilman Shoemaker, seconded by Councilman Savage to award the heating contract at the police garage to Hart's Fuels for the sum of \$2,000.00 and to award the lighting contract to Hoosick Electric for a sum of \$1,000.00. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

Supervisor Udwary appointed Councilman Savage as Chairman, Councilmen Patti and Shoemaker as members of a dog control committee. Clerk Wicks gave a brief description of the Towns roll in the New Dog Control Law that will go into effect January 1st, 1980.

Clerk Wicks also advised the committee that heir would be a state sponsored informational session at SUNY on June 19th for Town Clerks and Board Members and that there would be a session on June 20th for Dog Control Officers.

Supervisor Udwary stated that a list of applicants for the Planning Board and Zoning Board of Appeals vacancies will be studied and appointments made at the next meeting.

The date for the public meeting on Revaluation will be held at the Town Hall on Wednesday, May 22nd at 7:30 p.m.

A proposed local law on the Town Clerk's Office was read by Attorney Werger and given to each member of the Town Board for their study. A motion was made by Councilman Patti, seconded by Councilman Shoemaker that a public hearing be held on the proposed local law at 7:45 p.m. Wednesday June 13th at the Town Hall. The motion passed.

Clerk Wicks then asked if he could make a statement. He advised the board that it had been stated that it was illegal for the Town Clerk's Office to be located in his insurance office in West Sand Lake. Clerk Wicks then read the Attorney General's opinion from the Town Law that stated that it was not illegal as long as rent was not paid for the office. He asked that it be confirmed that no rent has been paid for the West Sand Lake Office. He then stated that it had been said that his wife was on the Town payroll. He denied that she had ever been paid and this was confirmed.

He then stated that there had been some confusion over his statement at the public hearing over running for office. Carl then stated that he was running for re-election as town Clerk on the Republican ticket.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Patti that the Supervisor be authorized to sign a street opening contract with the Department of Transportation of the State of New York in connection with the Sewer District. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Savage authorizing the Supervisor to sign a renewal contract with the New York State Electric and Gas Company to replace one expiring on June 10th, 1979. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

A request for a rate increase by the Rensselaer Cable Vision Corp. was discussed by Chairman Martin. He advised the board that their financial statement showed that they were losing money in all (3) towns and the City of Rensselaer. He also stated that they were proposing additional programming from Madison Square Garden and that this was part of the reason for the requested increase. Our present contract runs into May of 1980 and that no action had to be taken until that time if it was determined that the proposed service was not wanted.

A motion was made by Councilman Patti, seconded by Councilman Bresnahan that a public hearing be scheduled for a request in rates for the Rensselaer Cable Vision franchise. That the public hearing be scheduled for Wednesday June 20th at 7:30 p.m. The motion passed.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Savage that Maria Lynam, Assessor be empowered to attend an Assessors training session at Cornell University for (1) week at an expense to the Town of not more than \$300.00. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Shoemaker that the price of the Sub-Division Regulations be \$2.40 per copy which is the cost of printing. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Shoemaker authorizing Superintendent of Highways Scouller to attend a Superintendent of Highways school at Cornell for (3) days, the total Town expenditure not to exceed \$200.00. The following votes were cast on roll call: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes, Savage – Yes.

A resolution was offered by Councilman Patti, seconded by Councilman Bresnahan as follows: Now, therefore, BE IT RESOLVED:

- 1) That the specific object or purpose for which obligations are to be issued pursuant to this resolution is to finance the cost of a 1974 Traxcavator Model \$955L.
- 2) That the cost of such machine is \$42,500.00 and the plan of financing such remaining cost is as follows: Issuance of Statutory Installment Bond in the amount of \$21,000.00 with cash paid down in the amount of \$6,000.00 and a trade in of a used traxcavator having a value of \$15,500.00.

- 3) The following determinations are hereby made:

The International truck for the highway department has not arrived and no bonding action was taken on that subject.

A rezoning application from Jerome & Edith Hunt was submitted to the board. After some discussion a motion was made by Councilman Bresnahan, seconded by Councilman Savage that the rezoning request of Jerome & Edith Hunt be returned to the Planning Board with a recommendation that they conduct a public hearing in conjunction with the Town Board. The motion was approved.

Clerk Wicks advised the board that the town maps had not been updated in over 10 years and that he was receiving complaints as the newer streets were missing. Supervisor Udwary will consult with the Zoning Officer for recommendations.

A resolution was offered by Councilman Bresnahan, seconded by Councilman Patti authorizing Supervisor Udwary to enter into a contract of purchase with Harold Foster for the purchase of Sand & Gravel from his bank. On roll call the following votes were cast: Udwary – Yes, Bresnahan – Yes, Patti – Yes, Shoemaker – Yes.

Councilman Patti advised the board that Al Dobert is willing to meet with them over the Bon Acre Mall. The matter was deferred until next month.

Mr. Baniak asked why local people were not being considered for the swimming instructor. Mr. Patti explained that the person appointed was fully qualified and had participated in the program for many years.

Mr. Baniak then questioned the board about surpluses in the insurance account and the Street Light account. It was explained that other charges were pending on these accounts and that it was better to end the year with a surplus than a deficit.

The meeting was adjourned at 10:20 p.m. on a motion made by Councilman Bresnahan, seconded by Councilman Patti.

Also present were: Bob Fickies, Madolyn Carpenter, Charolette Foster, Vi Bedian, Joe Warren, Bernard Baniak, John Miadzielec, Emma Wicks, Frank Allen, John Donohue, Nancy Dyer, Mr. & Mrs. Smith, Mr. & Mrs. Monch, Douglas Kelley, Dan Holser and a group from Burden Lake and a group from Huntley Road.

Deputy Supervisor Bresnahan opened the meeting and had Clerk Wicks read the public notice of bids for grades 1 & 1a stone. Clerk Wicks then opened the only bid received from Troy Sand & Gravel.

The bid was as follows: for Alpine Sand, Lake Sand, Gravel, all stone (pea, 1 & 2 etc.) 3.00 per ton.

A resolution was offered by Councilman Patti seconded by Councilman Savage that the bid of Troy Sand and Gravel at the rate of \$3.00 per ton for sand, gravel and all stone be accepted. The following votes were cast on roll call: Bresnahan – Yes, Patti – Yes, Savage – Yes.

The Sand Lake Ambulance Report for April and May was read by John Miadzielec.

General Fund Warrant #6 in the amount of \$153,062.44 was approved on a motion by Councilman Patti, seconded by Councilman Savage.

Highway Fund Warrant #6 in the amount of \$75,062.44 was approved on a motion by Councilman Patti, seconded by Councilman Savage.

Correspondence: From Kestner Engineer's a progress report; from the Renss. County Health Dept. a public hearing on resources recovery on June 20th at 2 PM; from the Town of Nassau a notice on Cable TV.; the Planning Board minutes of May 2nd & 16th; from the Public Service Commission regarding a rate increase for Western Union; from NYS Energy Office regarding an energy code; the 1978 Annual Report of the Capitol District Planning Commission; from the Division of Housing & Community Renewal regarding the NYS Building Code; from the Department of Transportation regarding stop signs at Crystal Road and Mountain View Drive.

Committee Reports: Roads & Streets & Landfill & Police Commission; Bresnahan: The committees have been looking at streets that they have had complaints on.

Lighting District, Senior Citizens, & Insurance; Shoemaker: On Street Lights (1) light has been repaired and a request for another light is being investigated. The Senior Citizens are having a dinner tomorrow.

Youth Recreation & Dog Control; Savage: On dog control Chairman Savage and Town Clerk Wicks are to attend a meeting in Albany on the new dog control law on the 19th. The recreation field is being fertilized and limed. An additional area is being rough graded and will be finished in late summer. The Football & additional Baseball field will be worked on in the spring. Councilman Patti read the names of the appointments for the summer Youth Program. They are as follows: Lifeguards: Timothy Kushy, Pamela Skripak, Nick Burke, and Steven Harris. Supervisors & Instructors: Susan Clousen, Larrie Smead, Linda Wood, Cindy Middleton, Teresa Perrault, Debra Chennette, Kevin Brunich, Chris Cooke, Mike Kern, Nancy Malone, Valerie Long, Nancy Marshall, Cari Martin & Denise Hungerford.

A resolution was offered by Councilman Patti seconded by Councilman Savage that the above names be appointed for the Youth Program for 1979. On roll call the following votes were cast: Bresnahan – Yes, Patti – Yes, Savage – Yes, Udwary and Shoemaker, Absent. Councilman Patti also reported that swimming classes will be held at the beach this summer.

Town Buildings & Budget & Finance; Udwary: Councilman Bresnahan reported for Supervisor Udwary: the Building Committee is considering repairs or replacing the roof on the Town Hall, the heat is in and the electric will be in Friday at the Police Garage.

Sewer District: Attorney Werger advised the board that contract #3 which is the West Sand Lake Area is being advertised on Friday the 15th for bidding. It is expected that it will be about a \$2,000,000.00 project. Attorney Werger asked the board to authorize deeding an easement back and accepting another easement from Carl Beck.

A resolution was offered by Councilman Patti seconded by Councilman Savage that the 1st easement from Carl Beck be deeded back to him as it is unnecessary and that a second easement be accepted

because of a change in routing of the sewer line. The following votes were cast on roll call: Bresnahan – Yes, Patti – Yes, Savage – Yes, Udwary and Shoemaker, Absent.

A trailer that was installed at Burden Lake came under discussion. It was alleged by local residents that the Zoning Permit for this trailer should not have been issued by Zoning Officer LaFleur. They presented photos of the previous trailer and of the new trailer that was installed. They also presented a petition that was read by Clerk Wicks. The board will present the papers to Mr. LeFleur and ask him for a written explanation for the next Town Board meeting.

A petition was presented to the Town Board from a group of people in the area of Huntley Road regarding the proposed housing of Disabled and Retarded Children in a home on Huntley Road. The Petition is to be forwarded to interested parties by the Town.

A resolution was offered by Councilman Patti seconded by Councilman Savage appointment Vi Bedian to the Zoning Board of Appeals and Robert Philippi as a member of the Planning Board. The following votes were cast on roll call: Bresnahan – Yes, Patti – Yes, Savage – Yes, Udwary and Shoemaker were Absent. Mrs. Bedian's term expires in October 1979. Mr. Philippi's term expires in October 1984.

The board was advised of the public hearing on an increase in rates for cable TV to be held on June 20th at 7:30 p.m.

Deputy Supervisor Bresnahan advised the board that Robert LaFleur would update our highway map for the sum of \$200.00 this would not include printing.

A resolution was offered by Councilman Patti, seconded by Councilman Savage that the sum of \$200.00 be expended to update the Town Highway Map. On roll call the following votes were cast: Bresnahan – Yes, Patti – Yes, Savage – Yes, Udwary and Shoemaker – Absent.

That there would be children up to the age of 18.

That there would be no more than 11 children, with a minimum of 22 adults as supervisors.

That many state agencies would have to approve of the facility before it could be used.

Many persons stated that they were not concerned about children but felt that later on they might place adults in the home.

Allan Randell stated that he understood the purpose of the home and offered his support. Kay Langford stated that the hall has never catered to anyone but children.

Mr. Baniak asked what salary was being paid to Mr. Debus. Mr. Debus replied that it was \$2,600.00 as it was established in the budget.

Mrs. Wicks asked if Mr. Baniak was entitled to a copy of the budget as he did not work for the Town.

Clerk Wicks explained that when Mr. Baniak was terminated the budget was Town property and should have been returned. Mr. Baniak stated that it had his notes in it and that he was going to keep it.

Bob Fickies asked about the Planning Board appointments and why he had not been considered. Mr. Patti answered that the person appointed was the most qualified of those considered.

The meeting was adjourned at 10:00 p.m. on a motion made by Councilman Patti, seconded by Councilman Savage.

JUNE 20, 1979

The Special Town Board meeting was called to order at 7:30 pm at the Town Hall, Sand Lake, N.Y. with Supervisor Udwary presiding. The following answered roll call:

Supervisor Udwary – Present Councilman Shoemaker – Present
Town Clerk Wicks – Present Councilman Savage – Present
Councilman Bresnahan – Present Attorney Werger – Absent
Councilman Patti – Present

Also present were: Bob Fickies, Joe Warren, Ken Martin, George Schmead, Bill Henchey, Mr. & Mrs. Irving Sewell and others.

Supervisor Udwary opened the meeting by stating that it was called to hold a public hearing on request of the Rensselaer Cablevision to increase their Cable TV rates.

Clerk Wicks read the public notice of the hearing.

Supervisor Udwary read a letter from Rensselaer Cablevision advising the town that the current rates are in effect until July 1, 1980 and that additional proposed programming would not be available until that date unless the additional requested increase is made available at an earlier time.

Mr. Henchey, President of Rensselaer Cablevision had a chart to show expenditures and income and showed that the company had been operating at a loss. He showed that they had gained the expected density of subscribers. He indicated that the increase would have to be up to \$9.00 dollars from the current \$7.06 fro the basic charges. He outlined the additional programming that will be available and the cost of providing this additional programming.

He then opened the meeting to questions. The principal question seemed to be from Greenwood Acres in that they have been promised service but have not received it. Mr. Schmead stated that they would have service within 60 days.

The failure of the company to provide the service as outlined in the map that is on file in the Town Clerks Office. This area is generally on the East Side of Burden Lake. Mr. Henchey countered by stating that they had installed more miles of cable than was called for in the franchise.

When pressed he did state that he would review the matter with Mr. Schmead the next morning and would write the board advising them of what action would be taken.

Also present were: Vera Cole, Joanne Cole, Mary Hilt, Alice Tifft, Charlotte Foster.

The first order of business was the drafting of a resolution to appoint a Town Clerk to fill the vacancy created by the resignation of Carl Wicks as Town Clerk. A resolution was offered by Councilman Shoemaker, seconded by Councilman Savage that Charlotte Foster be appointed to the abovementioned position. Upon roll call the following voted: Supervisor Udwary – Yes, Councilman Bresnahan – Yes, Councilman Shoemaker – Yes, Councilman Savage – Yes, Councilman Patti – Absent. Mrs. Foster was sworn in by Supervisor Udwary and she continued the taking of the minutes of the meeting.

OLD BUSINESS:

SECTION 1. In anticipation of the sale of serial bonds hereinafter to be issued in the aggregate principal amount of One Million Four Hundred and Thirty-Five thousand (\$1,435,000.00) Dollars, authorized to be issued by a Bond Resolution of the Town Board of the Town of Sand Lake adopted on the 4th day of May, 1977, entitled:

"RESOLUTION of the 4th day of May, 1977 authorizing the issuance of Serial Bonds of the Town of Sand Lake, Rensselaer County, New York in the principal amount of Eleven Million Three Hundred and Forty Thousand (\$11,340,000.00) Dollars to pay part of the cost of the construction of Sand Lake Sewer District No. 1 in said Town."

there are hereby authorized to be issued and sold bond anticipation notes of the Town of Sand Lake in the aggrtegate principal amount of not exceeding One Million Four Hundred and Thirty-Five Thousand (\$1,435,000.00) Dollars. Such bond anticipation notes in such amount shall be issued in anticipation of the sale of serial bonds in like principal amount to pay part of the cost of the construction of Sand Lake Sewer District No. 1 in said Town.

SECTION 2. The Supervisor of the Town of Sand Lake is hereby authorized to sell at private sale the renewal bond anticipation notes herein authorized to be issued. Such notes may be sold and delivered at one time or from time to time, and if sold at different times, they shall be dated as of the respective dates of issue. Each of said notes shall mature not later than one year from its date of issue. The place of payment, denominations and all other terms, details and contents of said notes, including the interest rate on said notes and provision for redemption, if deemed desirable, shall be determined by the Supervisor of the Town.

SECTION 3. Said bond anticipation notes shall be signed by the Supervisor of the Town of Sand Lake, countersigned by the Town Clerk and shall have the corporate seal of said Town thereto affixed.

SECTION 4. There are presently outstanding the following bond anticipation notes which had been previously issued in anticipation of the sale of the bonds described above:

- 1) Bond Anticipation Notes Numbered 3, 4, 5 and 6 of 1978 in the amount of \$396,000.00, dated October 6, 1978, maturing October 5, 1979.
- 2) Bond Anticipation Notes Numbered 7-16, inclusive in the amount of \$1,000,000.00, dated October 6, 1978 and maturing October 5, 1979.
- 3) Bond Anticipation Note Number 17 in the amount of \$80,000.00 of 1978, dated October 6, 1978 and maturing October 5, 1979.

Such bond anticipation notes when they come due shall be refinanced by the issuance of renewal notes in the aggregate amount of One Million Four Hundred and Thirty-five Thousand (\$1,435,000.00) Dollars. The Supervisor's Report for the month of September as read by Secretary Debus showed total receipts in the amount of \$591,602.94 and total disbursements in the amount of \$607,878.70. The report was approved on a motion made by Councilman Shoemaker, seconded by Councilman Bresnahan.

The Zoning Officers Report was read by Clerk Foster – total fees for the month of September were \$5.

The Police Report for the month of September was read by Chief Teidman.

The Sand Lake Ambulance Report for the month of September was read by Sec. Lt. Charles Deutsch.

General Fund Warrant #10 and Highway Fund Warrant #10 were approved on a motion made by Councilman Bresnahan, seconded by Councilman Patti.

Frank Allen – Chairman of the Zoning Board of Appeals reported that there is a violation of the trailer ordinance. The trailer in question is located at Burden Lake and has to be removed within 60 days according to the Zoning Board. A letter of Intent was sent to Attorney Werger by the owner. Mr. Allen

also stated that two Public Hearings would be held – AP Associates – St. Henry's School; Lakeview Hotel – for Public Family Dwelling.

Correspondence: Clerk Foster noted that she had received a letter from the Dept. of Conservation stating that there were errors in the printing of manuals for small game hunting/fishing and trapping. As soon as the corrected ones arrive they will be available at the Town Clerk's Office.

Letter from NYS Office of the Aging – re: State Aid for recreation for the elderly. Application has been received by the State. Letter from Attorneys Clayman, Mead & Gallo – re: transfer of funds to Citibank. Rensselaer Co. Dept. of Highways – re: request formation of agricultural district. Rensselaer Co. Office of the Executive – re: 4th Annual Industrial Forum. Finnegan Associates – re: recap of Assessors meeting.

Committee Reports: Roads & Streets, Landfill, Police Commission – Councilman Bresnahan: Reported licenses have been filed with FCC for highway radios; Councilman Bresnahan noted that he had contracted the Association of Towns concerning the speed limit on town roads. He was informed that this cannot be done without contacting the State and also that legislation was in process to allow towns to set their own speed limits. Councilman Bresnahan requested Chief Teidman to do a survey of town roads to determine breakdown for State and County Jurisdiction.

Lighting District, Senior Citizens, & Insurance - Councilman Shoemaker: Reported that three street lights were out and would be replaced as soon as possible. Assessor's Salary – Assessor's salary was based on the fact that this position would be full-time and that a Board of Review would have to be setup. The Salary was broken down as follows: \$9,300 – full-time assessor; \$3,750 – clerk to assessor; \$400 – chairman of the Board of Review; \$350 each for 2 members to the Board of Review.

Playground – Why the tax cut from \$15,000 to \$3,000? Councilman Savage explained that the construction of the field was more important than getting equipment. He said that the equipment could be purchased at a later date. Councilman Savage offered his assistance to whoever became chairman of this committee in 1980. Supervisor Udwary commended Councilman Patti on his ability to maintain the Youth Recreation on a limited budget.
