Be it Resolved, the Sand Lake Town Board authorizes Town Attorney Scott Ely and Town Supervisor Nancy Perry to move ahead with the purchase of the Reichard's Lake Beach property; and

Be it Further Resolved, the following closing costs are authorized to purchase the property:

• Deed Recording: \$75

• TP-584: \$5.00

• Title Insurance: \$570.00

• Seller's Attorney Fees: \$1,500.00

• Back Taxes: \$5,141.67

Total costs for the property are \$7,291.67. However, upon the purchase of the property, Rensselaer County will forgive all back taxes, making the acquisition costs total \$2,150.00
